ROUTE MODIFICATIONS DUE TO IRONMAN ROAD CLOSURES on October 14, 2023

ROUTE 1 (HILO/KONA via Hamakua)

- ROUTE 1 to KONA: **CANCELLED STOPS:** at Kona Commons/Loloku St., Kona Courthouse on Kamakaeha Ave will be the last stop and temporary hub to connect with other routes.
- Route 1 to HILO: Will start from the Kona Courthouse stop time then proceed with the regularly scheduled routing to Hilo.

ROUTE 2 (Blue Line) KONA/HILO via Daniel K Highway

- ROUTE 2 to KONA: **CANCELLED STOPS:** at Kona Airport, Four Seasons Hualalai, Kona Village, & Kona Commons/Loloku St.

Kona Courthouse on Kamakaeha Ave will be the last stop & temporary hub to connect with other routes. Riders going to Kona International Airport can transfer to Route 202 or 203 from this stop.

- ROUTE 2 to HILO: **CANCELLED STOPS:** at Kona Commons/Loloku St, Kona Airport, Four Seasons Hualalai, & Kona Village.

Route to start from the Kona Courthouse on Kamakaeha Ave
Riders may take Route 202 or 203 from the Kona Airport and transfer to Route 2 to Hilo at this stop.

ADDED stop at Matsuyama Food Mart (HWY 190).

ROUTE 75

CANCELLED STOPS: at Four Seasons Hualalai, Kona Village, Kona Airport, NELHA, & Kona Commons/Loloku St.

Route to start & end at the Kona Courthouse on Kamakaeha Ave. Riders going to/from the Kona International Airport transfer from/to Route 202 or 203 at this stop.

- 6:15 am ROUTE 75 (S.bound to KONA) - Last stop at Kona Courthouse
- **ROUTE 75 at 6:55 am, 2:04 pm & 10:20 pm (S.bound to Kona) - CANCELLED**
- **ROUTE 75 at 7:10 am, 8:40 am & 10:35 pm (N.bound to KOA) - CANCELLED**
- 2:45 pm Route 75 (N.bound to KAPAAU) – Starts at Kona Courthouse, to travel via Hwy 190 & Waikoloa Village Rd to Waikoloa, then proceed as regularly scheduled.

ROUTE 90

NORTHBOUND to S. Kohala Resorts:

SOUTHBOUND to Pahala:

201 (Kona Trolley)

- **CANCELLED STOPS:** Kona Commons/Loloku St, Kona Brewing Co, Kona Coast Shopping Center & Alii Drive.

202 (Central Kona)
