ROUTE MODIFICATIONS DUE TO IRONMAN ROAD CLOSURES on October 26, 2024

All routes to start and end at the Kona Courthouse on Kamakaeha Ave which will be used as a temporary hub to connect with other routes, unless otherwise specified below:

ROUTE 1

CANCELLED STOPS: Loloku St (Kona Commons) & Kaiwi St

ROUTE 2

CANCELLED STOPS:

- (Westbound to KONA): Kona Village Resort, Four Seasons Resort, Kona Airport, & Loloku St/Kona Commons.
- (Eastbound to HILO): Loloku St (Kona Commons).

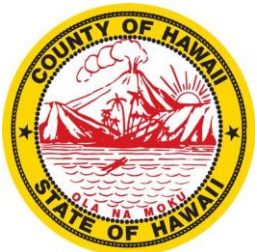
ROUTE 2 - Westbound to KONA

To travel from Waikoloa Marriott stop; travel via Waikoloa Rd to Mamalahoa Hwy (Hwy 190) to Kona with last stop at Kona Courthouse.

- ROUTE 2 @ 11:00 am Westbound to Kona – ADDED
- ROUTE 2 @ 4:45 pm Westbound to Kona – CANCELLED

ROUTE 2 - Eastbound to HILO

To start from the Kona Courthouse, then follow regularly scheduled routing from Ane Keohokalole Hwy to Hilo with additional time between stops added due to anticipated traffic delays.

ROUTE 75

CANCELLED STOPS:

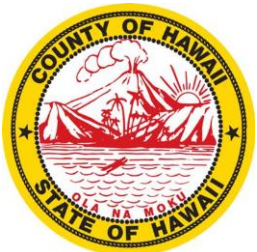
- (Southbound to Kailua-Kona): Loloku St (Kona Commons), Kona Airport, Kona Village Resort, Four Seasons Hualalai, & Makako Bay Drive.
- (Northbound to Kapa'au): Loloku St (Kona Commons), & Makako Bay Drive

ROUTE 75 @ 6:15 am (Southbound to Kailua-Kona):

To start 30 minutes earlier at 5:30 am. From Waikoloa Marriott stop; travel via Waikoloa Rd to Mamalahoa Hwy (Hwy 190) to Kona.

ROUTE 75 @ 2:45 pm (Northbound, Kona to Kapaau):

To begin at the Kona Courthouse on Kamakaeha Ave.

ROUTE 80 (North/Westbound to S. Kohala Resorts & Kona)

- ROUTE 80 @ 03:15 am:
To travel as regularly scheduled, ending at Kona Courthouse instead of Loloku St/Kona Commons.
- ROUTE 80 @ 03:35 am:
To travel as regularly scheduled to Waikoloa Beach Marriott, then re-route via Waikoloa Road (Waikoloa Village) & Mamalahoa Hwy 190 to Kona, ending at Kona Courthouse instead of Loloku St. Passengers heading to Kona Airport, Kona Village Resort or Four Seasons Hualalai to stay on board bus for the 07:15 am run (to Hilo) to get to their destination.
- ROUTE 80 @ 03:35 am ASSIST - ADDED:
To travel as regularly scheduled 03:35 am schedule to Waikoloa Beach Marriott, then re-route via Waikoloa Road (Waikoloa Village) & Mamalahoa Hwy 190 to Kona, ending at Kona Courthouse instead of Loloku St (Kona Commons).
- ROUTE 80 @ 04:15 am:
To travel as regularly scheduled to Waikoloa Beach Marriott, then re-route via Waikoloa Road (Waikoloa Village) & Mamalahoa Hwy 190 to Kona, ending at Kona Courthouse instead of Loloku St/Kona Commons
- ROUTE 80 @ 05:00 am - CANCELLED
- ROUTE 80 @ 11:00 am - CANCELLED (riders may use ROUTE 2 @ 11:00 am to SKR/Kona)
- ROUTE 80 @ 7:15 pm:
To travel as regularly scheduled to Waikoloa Beach Marriott, then re-route via Waikoloa Road (Waikoloa Village) & Mamalahoa Hwy 190 to Kona, ending at Kona Courthouse instead of Loloku St/Kona Commons. Passengers heading to Kona Airport, Kona Village Resort or Four Seasons Hualalai to stay on board bus for the 10:47 pm run (to Hilo) to get to their destination.

ROUTE 80 (East/Southbound to Hilo):

- ROUTE 80 @ 07:30 am:
To start at 07:15 am from Kona Courthouse and proceed as regularly scheduled to Hilo. (NO stop at Loloku St/Kona Commons).
- ROUTE 80 @ 1:55 pm
To start at 2:30 pm from Hilton Waikoloa and proceed as regularly scheduled to Hilo. (NO stops at Kona Airport, Four Seasons Hualalai, or Kona Village Resort).
- ROUTE 80 @ 2:45 pm
To start from Kona Courthouse and proceed as regularly scheduled to Hilo. (NO stop at Loloku St/Kona Commons).
- ROUTE 80 @ 4:00 pm & 4:35 pm
To start from Hilton Waikoloa, proceed as regularly scheduled to Hilo. (NO stops at Kona Airport, Four Seasons Hualalai, or Kona Village Resort)

ROUTE 90

CANCELLED STOPS:

Loloku St (Kona Commons), Makako Bay Dr (WHEA/NELHA), Kaiminani Dr, Four Seasons, Kona Village Resort, Fairmont Orchid, Mauna Lani, Hapuna Beach Resort, & Mauna Kea Resort.

• **ROUTE 90 (NORTHBOUND):**

To operate as regularly scheduled until it reaches Keauhou Shopping Center, travel to the Kona Courthouse on Kamakaeha Ave, then travel via Hwy 190 & Waikoloa Village Rd to Hilton Waikoloa & ending at Waikoloa Marriott stop.

• **ROUTE 90 (SOUTHBOUND):**

To start from the Hilton Waikoloa stop and travel via Waikoloa Village Rd & Hwy 190 to Kona with additional stop at Kona Courthouse on Kamakaeha Ave, then proceed as regularly scheduled to Oceanview.

ROUTE MODIFICATIONS DUE TO IRONMAN ROAD CLOSURES on October 26, 2024

ROUTE 201 (Kailua-Kona to Keauhou)

CANCELLED STOPS: Loloku St (Kona Commons), Palani Rd (Kona Coast Shopping Center), Alii Drive.

The Kona Courthouse on Kamakaeha Ave will be used as a temporary hub to connect with other routes and will travel from/to the Kona Courthouse on Kamakaeha Ave via Highway 19 to/from Keauhou Shopping Center.

ROUTE 202 (Central Kona)

CANCELLED STOPS: Loloku St (Kona Commons), Kaiwi St, Makako Bay Drive, & Kona Airport.

Route will travel between Kailua-Kona and Central Kona.

The Kona Courthouse on Kamakaeha Ave will be used as a temporary hub to connect with ROUTES 75, 80, 90 & 201.

ROUTE 203 - CANCELLED

ROUTE 204 (Keauhou to S. Kona/Captain Cook)

CANCELLED STOPS: Loloku St (Kona Commons), Henry St, Kona Courthouse.

Route to travel between Keauhou and Captain Cook.

Keauhou Shopping Center will be used as a temporary hub to connect with ROUTES 90 & 201 to/from Kailua-Kona.
